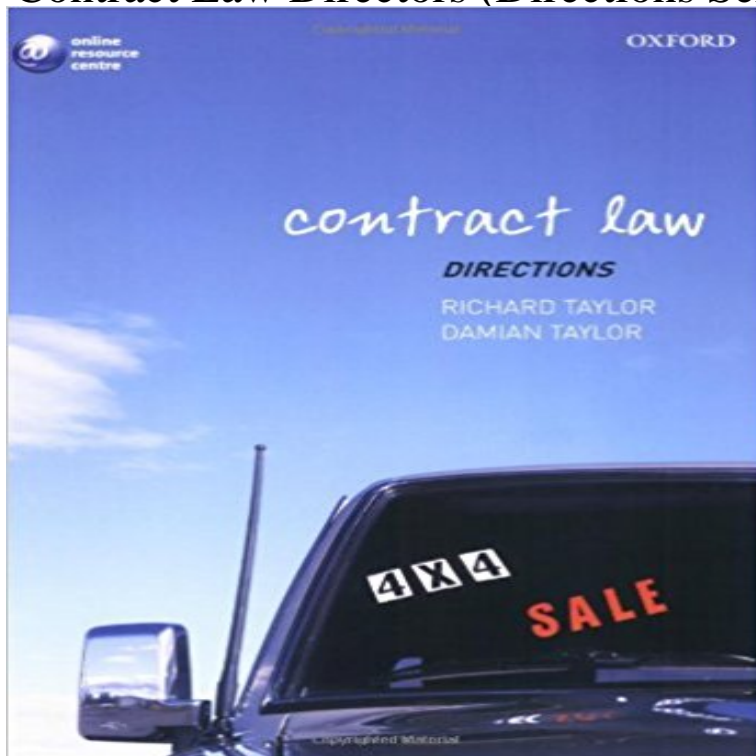


## Contract Law Directors (Directions Series)
