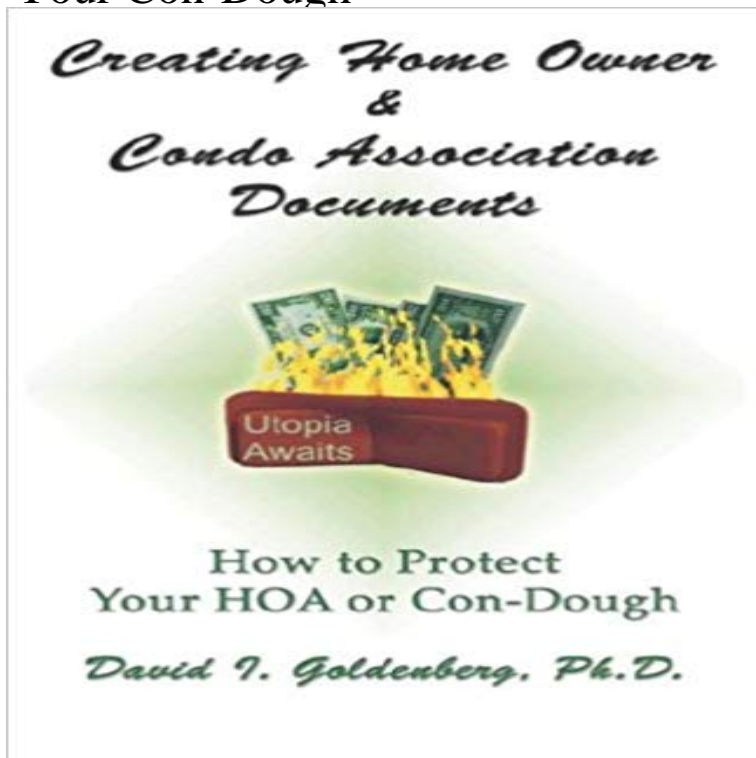


# Creating Home Owner & Condo Association Documents: How to Protect Your Con-Dough

Dr. Goldenberg specializes in developing practical solutions to top management problems in business economics, corporate strategy and governance. His work is original and effective. It ranges from high theory in creating new ways to handle problems to low cunning in implementing his recommendations. Moving into a Homeowners Association [HOA] and later a Condo exposed Dr. Goldenberg to the legalistic methods of governing HOAs and Condos. He found them appallingly irrational, ineffective and inefficient. Unless, of course, the real aim was to promote full-employment among attorneys, politicians, and bureaucrats.
