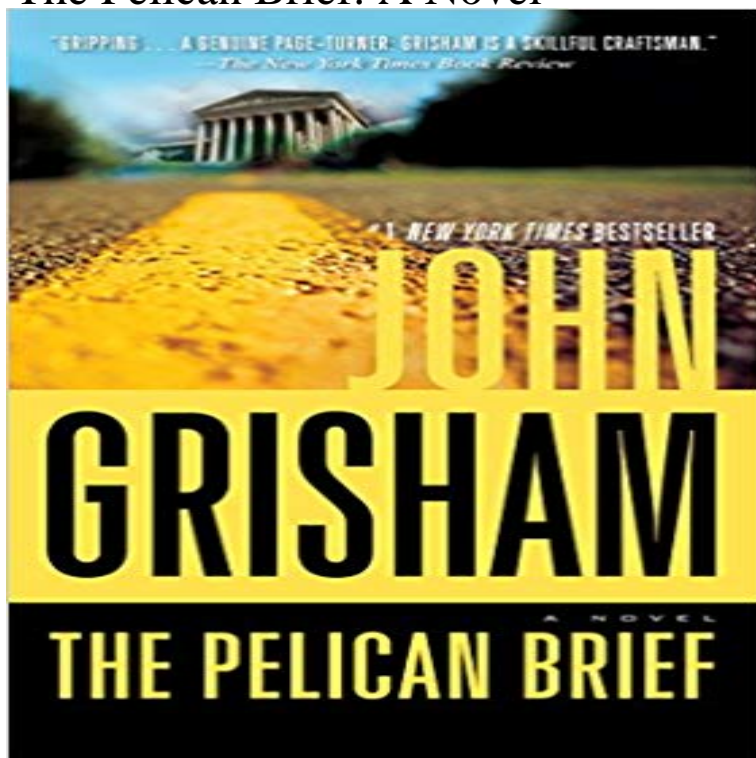


The Pelican Brief: A Novel
